

## Financial Adventure, LLC & Pampered & Productive Privacy Policy

Financial Adventure, LLC ("Company", "we", or "us") provides access to information through our websites accessible at [www.FinancialAdventure.com](http://www.FinancialAdventure.com) and [www.PamperedAndProductive.com](http://www.PamperedAndProductive.com) (the "website") and we may provide the ability to use certain functionalities of the website or provide services of various kinds (the "services"). We consider the privacy of our visitors to be extremely important. This Privacy Policy describes the types of personal information that is collected and recorded by us and how we use it. Our commitment to you is that we will not use or disclose information collected from you other than as described in this policy. This Privacy Policy applies solely to information collected by this website. It will notify you of the following:

1. What personally identifiable information is collected from you through the website, how it is used and with whom it may be shared.
2. What choices are available to you regarding the use of your data.
3. The security procedures in place to protect the misuse of your information.
4. How you can correct any inaccuracies in the information.

By using this website, you accept the terms set forth in this Privacy Policy and in our Terms and Conditions posted on this website. Persons and organizations with permission to use the service are considered "Registered Users". You may view portions of the website even if you are not a registered user.

### Information Collection, Use, and Sharing

We are the sole owners of the information collected on this site. We only have access to collect information that you voluntarily give us via email or other direct contact from you. We will not sell or rent this information to anyone.

We will use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, e.g. to ship an order.

Unless you ask us not to, we may contact you via email in the future to tell you about specials, new products or services, or changes to this Privacy Policy.

### Your Access to and Control Over Information

Our website is not directed to children and children are not eligible to use our services. Protecting the privacy of children is very important to us. We do not collect or maintain personal information from people we actually know are under 18, and no part of our website or service is designed to attract people under 18. If we later learn that a user is under 18, we will take steps to remove that user's personal information from our databases and to prevent the user from utilizing the website and the service.

### Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

Wherever we collect sensitive information (such as credit card data), that information is encrypted and transmitted to us in a secure way. You can verify this by looking for a closed lock icon on your web browser, or looking for "https" at the beginning of the address of the web page.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a secure environment.

Although we strive to provide security for information in our possession and control, no security system can prevent against all potential security breaches, and we bear no liability for uses or disclosures of personal information or non personal information arising in connection with the theft thereof. Be aware, however that the internet is not 100% secure, and we cannot guarantee that unauthorized third parties will never be able to defeat those measures or use your personal information for improper purposes. We cannot ensure the security of any information transmitted to us over the internet, and we accept no liability for any unintentional disclosure of such information. You acknowledge that you provide your personal information at your own risk. You also acknowledge that many portions of the website are password protected. Do not share your passwords with anyone. You are solely responsible for any actions taken on the website under your account. ### **Registration**

In order to use this website, a user must first complete the registration form. During the registration a user is required to give certain information (such as name and email address). ### **Orders**
